*The AFR was submitted and was successfully accepted without adjustments.

*The Town is signed up for EAP insurance.

EMS:

Cardiac monitors 3 units in service. They are used every day on every call. We have applied to replace the cardiac monitors with the AFG grant. Have not received a response. The monitors have annual maintenance and testing every year and one of the monitors failed. It was sent to the manufacturer with a quote of \$8200 To fix. To purchase a Refurbished Monitor \$25,000, new \$35,000, high quality \$40,000. Currently have a loner while a decision is made. The Zoll representative met Matt this week. A discussion was held with the board. Attorney White stated that due to the cost it would need to be put out to bid unless there is a contract that we could piggyback off of. More information will be gathered for a future meeting on how to proceed.
