### REQUEST FOR RELEASE OF FUNDS

On or about March 19, 2026, the Town of Corinth will submit a request to the New York State Homes & Community Renewal (HCR) through the New York State Housing Trust Fund Corporation (HTFC), for the release of \$510,000 in HOME funds under Title II of the Cranston-Gonzalez National Affordable Housing Act (NAHA) of 1990, in accordance with section 288 (42 U.S.C. 12838), to authorize the Town of Corinth to undertake a project known as Corinth MHR, for purposes of mobile home replacement of 3 homes within the Town of Corinth with an estimated total project cost of \$840,000.

The activities proposed are Categorically Excluded under HUD regulations at 24 CFR Part 58 from National Environmental Policy Act requirements.

This is the first tier of review in a 2-tiered process. The specific addresses of homes are not known at this time because the participating property owner identification process is ongoing. Therefore, under 24 CFR Part 58.15 (Tiering) and 24 CFR Part 58.32 (Project Aggregation), the Town of Corinth will use a tiered approach and Tier 2 site specific reviews will be completed for those laws and authorities not addressed in the Tier 1 broad review for each address under this program when addresses become known. No physical work will begin on properties until all levels of environmental review are complete and found to be in compliance. Tier 1 review addresses specific environmental factors for which compliance has been documented, regardless of specific site locations. It prevents repeating the same compliance factors on a Tier 2 site-specific basis, once all participating homeowners are known.

All comments received by March 18, 2026, will be considered by the Town of Corinth prior to authorizing submission of a request for release of funds.

#### ENVIRONMENTAL CERTIFICATION

The Town of Corinth certifies to HTFC that C. Eric Butler in his capacity as Certifying Officer consents to accept the jurisdiction of the Federal Courts if an action is brought to enforce responsibilities in relation to the environmental review process and that these responsibilities have been satisfied. HTFC's approval of the certification satisfies its responsibilities under NEPA and related laws and authorities and allows the Town of Corinth to use Program funds.

#### OBJECTIONS TO RELEASE OF FUNDS

HTFC will accept objections to its release of funds and the Town of Corinth's certification received by April 3, 2026, or for a period of fifteen days following its actual receipt of the request (whichever is later) only if they are on one of the following bases: (a) the certification was not executed by the Certifying Officer of the Town of Corinth; (b) The Town of Corinth has omitted a step or failed to make a decision or finding required by HUD regulations at 24 CFR Part 58; (c) the grant recipient or other participants in the project have committed funds or incurred costs not authorized by 24 CFR Part 58 before approval of a release of funds by HTFC; or (d) another Federal agency acting pursuant to 40 CFR Part 1504 has submitted a written finding that the project is unsatisfactory from the standpoint of environmental quality. Objections must be prepared and submitted in accordance with the required procedures (24 CFR Part 58, Section 58.76) and shall be addressed to:
